The total mass of the binary after the merger is smaller than that of the initial black holes for unequal-mass binaries, while the total mass is exactly the same as that of the initial black holes for equal-mass binaries. During the merger process, the heavy black hole moves quickly from the vicinity of the large mass black hole to the common center of mass of the binary, leading to an inevitable merger, while the light hole travels slowly in the equal-mass system and spends more time around the center of mass of the equal-mass system, thus causing more time of coalescence. The final mass of the equal-mass binary is higher than that of the unequal-mass binary.
